200 South Wacker Fitness Center Rules and Regulations

200 South Wacker contains a Fitness Center available for Tenants' use. The Fitness Center is located on the lower level and is equipped with basic cardiovascular machines and strength stations. There are men's and women's locker rooms with showers and lockers.

- 1. The Fitness Center will be open 24 hours a day 7 days a week. Please note, heat and air conditioning is provided from 7am-6pm Monday-Friday and 8am-1pm Saturdays only.
- 2. The Fitness Center is for the use of building employees only; friends, relatives, or visitors are not permitted in this facility. Employees must be a minimum 18 years of age.
- 3. Each tenant is responsible for controlling and monitoring access to these facilities, ensuring the access cards are issued only to an employee and prohibiting its employees from lending their access cards to non-employees.
- 4. Each tenant is responsible for returning access cards to the Office of the Building upon vacating the Building. If a tenant's card is not turned in upon vacating the Building, or is lost or stolen, the employee shall pay 200 South Wacker for the cost of voiding and replacing the cards.
- 5. All persons using exercise equipment and showers agree to do so at their own risk and agree to operate all equipment as intended and in accordance with the manufacturers' instructions.

- 7. The use of lockers is during workouts only. The Cleaning staff is instructed to clean out all lockers after 11:00 p.m. every night.
